SUBDIVISION EXEMPTION REQUEST, MARY WALTER, FILE NO. 2024-01

Mary Walter wishes to separate 15 acres m/l from an existing 259.3-acre parcel. The proposed 15-acre parcel is located on the east Boundary of Padilla Produce property, on the south Side of County Road C, just east of Highway 207. The property will be used for the construction of a stick built home for her granddaughter.
