APPROVE A RESOLUTION SUPPORTING THE SOUTHEASTERN COLORADO WATER CONSERVANCY DISTRICT'S EFFORTS TO PROTECT AGRICULTURAL WATER RIGHTS IN THE ARKANSAS RIVER BASIN

Motion by Elliott, seconded by Arbuthnot to approve the following resolution:

A RESOLUTION BY THE CROWLEY COUNTY BOARD OF COMMISSIONERS SUPPORTING THE SOUTHEASTERN COLORADO WATER CONSERVANCY DISTRICT'S EFFORTS TO PROTECT AGRICULTURAL WATER RIGHTS IN THE ARKANSAS RIVER BASIN.

WHEREAS, irrigated agriculture is integral to the history, economy, culture, and future of the Arkansas River Basin; and

WHEREAS, protecting the quantity and maintaining the quality of water in the Arkansas River is vital to maintaining irrigated agriculture in the Arkansas River Basin; and

WHEREAS, Crowley County has lands located within the Southeastern Colorado Water Conservancy District; and

WHEREAS, Southeastern Colorado Water Conservancy District entered into an Intergovernmental Agreement with the City of Aurora in October 2003, intended in part to settle litigation between Southeastern Colorado Water Conservancy District and Aurora, facilitate use by Aurora of Fryingpan-Arkansas Project facilities, and limit the future purchase and transfer by Aurora of water out of the Arkansas River Basin; and

WHEREAS, Aurora is proposing additional purchase of water in the Arkansas River Basin for transfer out of the basin.

NOW THEREFORE BE IT RESOLVED, Crowley County supports the Southeastern Colorado Water Conservancy District Resolution and efforts to assure compliance with the 2003 IGA.
