APPROVE A RESOLUTION AUTHORIZING THE DOLA LOCAL PLANNING CAPACITY GRANT AND MATCHING FUNDS Motion by Elliott, seconded by McMillian to approve the following resolution:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CROWLEY COUNTY, COLORADO, AUTHORIZING THE DOLA LOCAL PLANNING CAPACITY GRANT AND MATCHING FUNDS

WHEREAS, Crowley County collectively with the 6-County Southeast region pursuant to the provisions of C.R.S. § 29-1-204.5 formed the Southeast Colorado Regional Housing Authority ("SECRHA"); and

WHEREAS, the voters of Colorado approved Proposition 123 in 2022 creating the State Affordable Housing Fund to make certain funds available to local governments as defined by CRS-29-32-104; and

WHEREAS, Crowley County, Colorado is a Statutory County duly and regularly organized and validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the state of Colorado and opted into Proposition 123 funding and programming; and

WHEREAS, an additional 21 local governments which are members of the SECRHA also opted into Proposition 123 funding and programing; and

WHEREAS, the Board of County Commissioners authorizes the County staff to submit the Department of Local Affairs ("DOLA") Local Planning Capacity Grant to benefit all local governments within the SECRHA who have opted into Proposition 123 for the benefit of developing codes to fast track development, plan affordable housing projects, inventory public properties for housing, assist with regional collaboration for funding projects, or any other authorized activities allow by the grant to achieve the development of affordable housing baselines; and

WHEREAS, Crowley County authorizes the required matching funds for the Grant, will serve as the fiscal agent for the administration of the Grant, and has executed a Memorandum of Understanding with Southeast Colorado Enterprise Development for the reimbursement of said matching funds from the region.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CROWLEY COUNTY, COLORADO, that:

Crowley County hereby authorizes the submittal and matching funds for the Regional DOLA Local Planning Capacity Grant Program for the 6 County region.

CCCF: There are currently 1,387 beds filled at the facility. There are 13 employment vacancies. They had 29 inmates graduate the GED program. A PTSD program for vets was offered to the inmates and it was successful. Core Civic is focusing on retention, and the facility is currently surpassing industry standards.
