# DR. LISA SCHLOTTERHAUSEN, SOUTHERN COLORADO ECONOMIC DEVELOPMENT DISTRICT, INFORMATION ABOUT NEW BROADBAND OPPORTUNITY

Lisa talked about the Colorado Broadband Office's Broadband, Equity, Access, and Deployment (BEAD) program. The program goal is to connect 99% of Colorado households and fund programs that address our state's digital divide. Sugar City, Ordway, Crowley, Olney Springs, and some unincorporated areas are within the eligible area. The estimated cost for the broadband project for Crowley County is \$8,100,000. The grant would cover 75% of the cost with a 25% match. The match amount would be covered by SECOM, Crowley County, and the four towns. The grant application will open in late August. Arbuthnot mentioned that he is struggling with the cost of the project. He knows that the towns do not have money to meet the match, and the County would have to cover that. This is something the commissioners will consider. Lisa will reach out again in August to see if they are interested in applying for the grant.
