OTHER BUSINESS OR DISCUSSION - CONTRACT & PROCUREMENT POLICY

The Division of Homeland Security & Emergency Management conducted site visits on September 11, 2024 and November 14, 2024. The visit pointed out that our Contract and Procurement Policy had a number of deficiencies. Due to the complexity of State and Federal grant regulations it was decided it would be best to outsource this revision of this policy and procedure. Two different law firms were discussed. It was decided that we will ask Kanthaka Group to prepare this for us. Motion by Powell, seconded by McMillian to request Kanthaka Group to review our current Contract and Procurement Policy, and to revise it to meet all Federal and State requirements.

MONTHLY PRISON MEETING

The board conducted the monthly prison meeting with a representative of Crowley County Correctional Facility. No representatives attended from Arkansas Valley Correctional Facility. Those in attendance were:

Commissioners: Elliott. McMillian and Powell Deputy Clerk to the Board: LaShelle Benbow

CCCF: Assistant Warden Steve Brown Lobbyist: Joan Andrew Green Turner

CCCF: the current bed count is 1,499. CCCF recently received their ACA accreditation certificate. Currently, they have a class of 16 who will graduate in February, of which 12 are correctional officers. This will leave the facility with 10 correctional officer vacancies. They are looking for a GED instruction, mental health coordinators, and drug and alcohol treatment professionals. They continue to focus on retention. The wastewater lagoon dredging project was completed last week and it is fully up and running. 2025 projects include replacing the kitchen floor, upgrading the greenhouse, and full-facility upgrade of the fire alarm system and lighting. McMillian informed him that neighboring civilians have complained about the prairie dog problem. Brown stated that the USDA guy had visited the prison regarding the prairie dogs. He will follow up on that visit to see what was discussed.

No further business appearing, the meeting was recessed.
